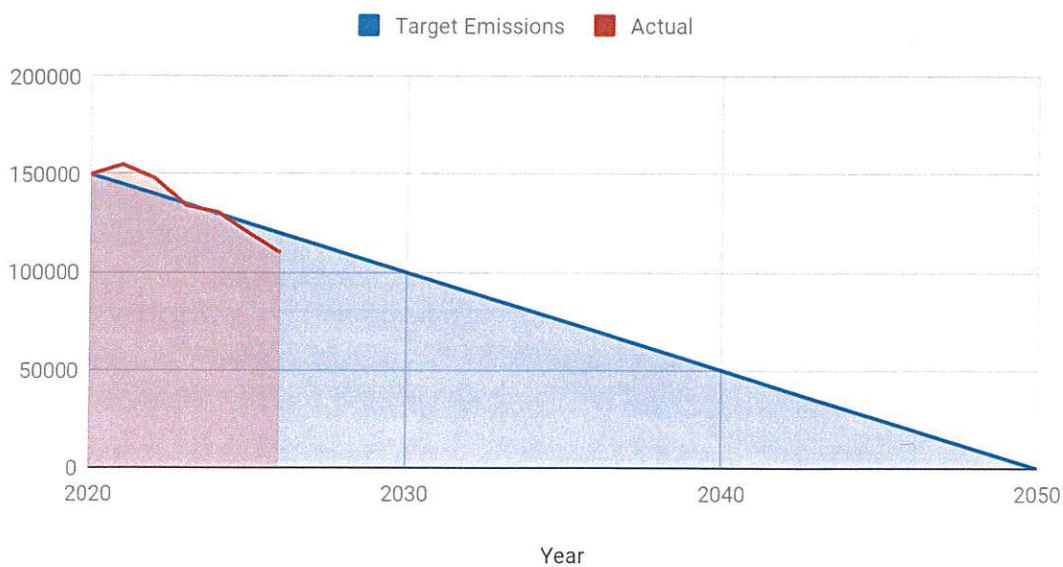
Emissions reduction targets
